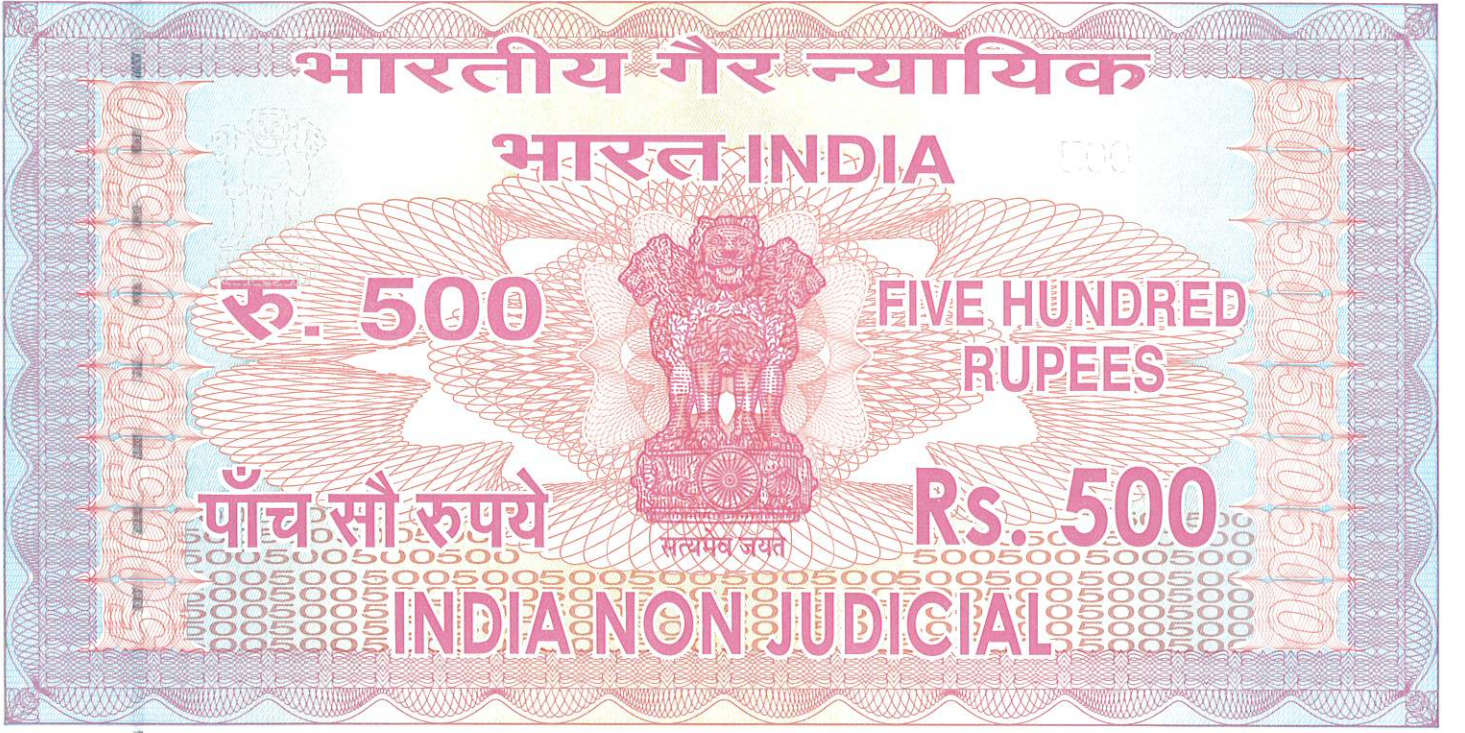

Kharat** (hereinafter referred as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

A) Progressive Education Society's Modern College of Arts, Science and Commerce (Autonomous), Ganeshkhind, Pune 411016, the First Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.

B) Dhadeshwar Vidya Va Krida Pratishtan's Dhadeshwar Shikshanshastra Mahavidyalaya Dhayari Pune 411041, the Second Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.

C) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.

D) The Parties intent to cooperate and focus their efforts on cooperation in overall excellence in teaching learning and evaluation

E) Both Parties, being legal entities in themselves, desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL UNDERSTANDING SETFORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to Second Party in developing suitable teaching / training systems, keeping in mind the needs of the region of Mentee Institution.

The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

The budding graduates from the institutions could play a key role in, excellence innovation and competitiveness. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their knowledge.

Curriculum Design: First Party will give valuable inputs to the second Party in teaching / training methodology and suitably customization of the curriculum so that the students fit into the industrial scenario of their region meaningfully.

Training & Visits: Interaction amongst the teachers and students of both institution will give an insight in to the latest developments / requirements of the higher education; the First Party to permit the Faculty and Students of the Second Party to visit its institutional facilities and also involve in training programs about teaching, learning and evaluation for the Second Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from there rural background to working career. The First Party will provide its labs / workshops / libraries for the hands-on training of the learners of the Second Party as per the availability of the facilities.

Research and Development: Both Parties have also agreed to carry out the joint research activities.

Capacity development Programs: First Party to train the students and teachers of Second Party on the emerging trends in higher education in order to bridge the skill gap and make them industry ready.






Guest Lectures: First Party to extend the necessary support to deliver guest lectures to the students of the Second Party (inter alia, by video conferencing) on the relevant topics/ trends and in-house requirements.

Faculty Development Programs: First Party to train the Faculties of Second Party for imparting training, in new pedagogies, innovative assessment and research methodology and other relevant topics.

Placement of Trained Students: First Party will actively engage to help the delivery of the soft skills and support in placement of students of the Second Party.

Guidance on Assessment and Accreditation Process: First Party will provide Guidance on Assessment and Accreditation Process by arranging Seminars/Workshops/Visits. They will also guide on NAAC process, Documentation required, Role of IQAC in quality enhancement of the institution leading to completion of NAAC process.

Funding: The funding for the Scheme shall be followed as mentioned in the Mentor-Mentee Guidelines prepared by the State Government. First Party and Second Party as joint venture will be raising the required funds through Institutional Social Responsibility (ISR) or Corporate Social Responsibility (CSR).

CLAUSE 3: REPORTING

Both parties will submit monthly /quarterly report to District Level Committee, UniversityLevel Committee, Director, Technical Education and RUSA (Maharashtra) about the activities

CLAUSE 4: VALIDITY

This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms and prior written permission from the competent authority of University during which period the Second Party, as the case may be, will take effective steps for implementation of this MOU.

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties must discharge their obligations.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **Pune City**.




Introduction

The Digital Water Management project will perform an important task of awareness and capacity building of local residents in order to assess soil and water health of their area. Once they are enabled to do so, they would then impart this knowledge with others and regularly carry out the required activities for assessment and improvement of the same. The ultimate goal of this noble cause is to achieve water and environmental sustainability in the villages via capable local volunteers independently.

For the given time period, all of the project's stakeholders are voluntarily collaborating toward accomplishing this worthy goal.

Purpose

The purpose of this Memorandum of Understanding (MoU) is to establish the collaborative framework between DWMC and college students under which Participants will monitor the water, related weather and environmental conditions for water sustainability in the village for the given time period.

Methodology of Work

- The Participants would receive orientation from DWMC in conjunction with the knowledge partners.

The In Search Environmental Solutions, Pune, India (IES) and The Progressive Education Society's Modern College of Arts, Science and Commerce, Ganeshkhind, Pune, India have agreed to cooperate in research on biodiversity, taxonomy and phylogeny of arachnids of India. This cooperation will start from January 2024.

1. The IES and the MCASC will strive to accomplish the following objectives to promote scientific exchange and collaboration between the two institutions in the field of biodiversity, taxonomy and molecular phylogeny of arachnids of India:

(1) Collection & exchange of materials related to scientific research and education.

(2) Development of a phylogenomic data from the collected material.

(3) Development of cooperative research between IES & MCASC.

(4) Jointly publish the relevant work in international peer reviewed journals.

(5) Guiding students for research related to bio-diversity, systematics, phylogeny and biogeography through lectures and field visits. (Workshops, seminars, conferences etc.)

2. The aim of the first cooperative project between the two institutions involved the collection & exchange of arachnids from India. The MCASC will be responsible to provide all the laboratory infrastructure and facilities for molecular procedures to the visiting workers of IES. The IES will be responsible to collect and provide specimens and/or tissues required for the study, as well as arrange for necessary permits for this collection. IES will be responsible to provide all necessary expertise in identification and subsequent analyses for testing the hypothesis. The data generated from this study will be jointly published in reputed journals. The success of this first project will serve as a test run for a long term collaboration between the two institutions.

3. MCASC will provide material support & funding for molecular work required during this study. Students from MCASC will be involved in this study under the expert guidance of Dr. Deshabhushan Bastawade & Shauri Sulakhe.

5. The agreement can be revised by mutual agreement between the IES and the MCASC.

6. This agreement will be effective after the date of signature by representatives of the IES and the MCASC, and will be considered null and void if one of the two parties does not deliver on their commitments.

Nestled within the vibrant city of Pune, Maharashtra, it operates under the esteemed umbrella of Savitribai Phule Pune University. With a legacy of excellence, the college caters to students at the undergraduate, postgraduate, and post-doctoral levels.

Modern college, Ganeshkhind (Autonomous), hereinafter referred to as FIRST PARTY.

AND

Vasundhara Club (VC) is a Pune based Proprietary firm dedicated to environment, wildlife, energy, air, water. Sole aim of VC is to create awareness and initiate when possible actions through various activities like film shows, audio - visual lectures, workshops, photography exhibitions, nature walks, cultural programmes and short festivals.

VC is a movement, an attempt to change minds, attitudes and if possible policies also. It strives to make children, youngsters and citizens more concerned about Vasundhara and need to understand our priceless natural heritage. Moto of the Club is to Preserve, Protect, Save the Earth.

Both parties as above have expressed a desire of entering a MOU to meet their respective objectives, which are set out herein below.

WHEREAS

Both the parties are long involved in environment related programs, events, workshops, and green initiatives. Through this Memorandum of understanding we endeavour to formalize these activities in a formal structured manner.

Part A

Environmental Initiatives by college

- 1) The **Vasundhara Club** offers various environmental consciousness related programs consistently. Hereafter students of Modern College of Arts, Science and Commerce,


- (Autonomous) Ganeshkhind will be volunteers and participants in the arena of programs and environmental initiatives distinctly and openly offered by Vasundhara Club.

- 4) Mutual Understanding Clause: In case of a disagreement on any of the points on the current MOU, both the parties hereby agree to settle the matter through mutual understanding in order to successfully take forward the agreement and maintain cordial relationship.
- 5) Period of MOU : That the period of MOU shall be for a period of **Five (5)** years with effect from **19.06.2024** to **19.06.2029** Parties shall have the option to renew the said period of MOU for a further period as mutually agreed.
- 6) **Termination** :
 - a) Any of the parties shall be entitled to terminate this MOU forthwith by a written notice in the event of any of the following:
 - Any breach of the conditions of this MOU or when any of the parties indulges in illegal, immoral activities that cause nuisance / disturbance.
 - When If ownership and control of any of the party is taken over by persons other than existing owner.

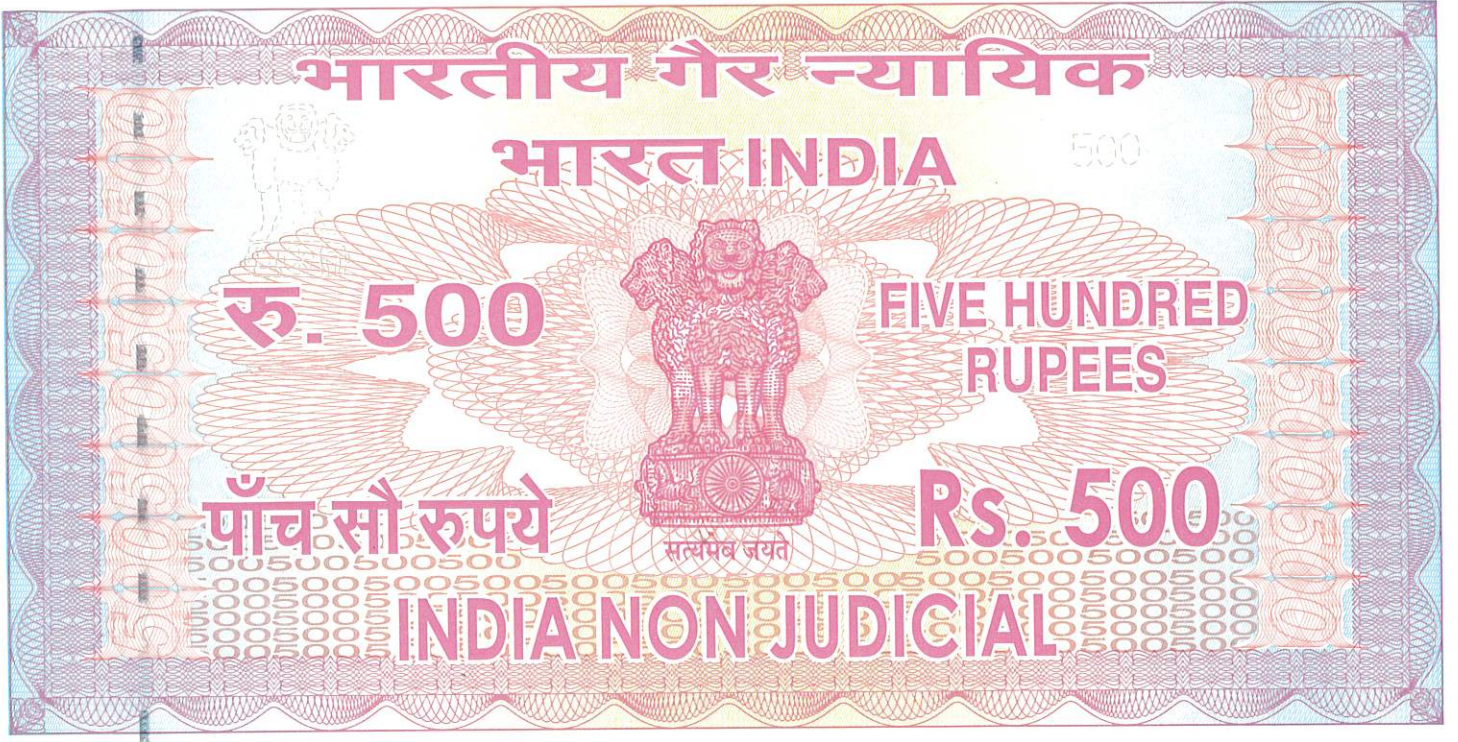

PES Modern College of Arts, Science & Commerce, Popularnagar, Warje, Pune 411058, **the Second Party**, and represented herein by its, **PRINCIPAL Dr. Varsha M. Bapat**, (hereinafter referred to as "**Second Party**", which expression, unless excluded by or repugnant to the subject or context shall include its successors – in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

- A) Progressive Education Society's Modern College of Arts, Science and Commerce (Autonomous), Ganeshkhind, Pune 411016, the First Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.
- B) PES's Modern College of Arts, Science and Commerce, Popularnagar, Warje, Pune 411058, the Second Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.
- C) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- D) The Parties intent to cooperate and focus their efforts on cooperation in overall excellence in teaching learning and evaluation



E) Both Parties, being legal entities in themselves, desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL UNDERSTANDING SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to Second Party in developing suitable teaching / training systems, keeping in mind the needs of the region of Mentee Institution.

The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

The budding graduates from the institutions could play a key role in, excellence innovation and competitiveness. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their knowledge.

Curriculum Design: First Party will give valuable inputs to the second Party in teaching / training methodology and suitably customization of the curriculum so that the students fit into the industrial scenario of their region meaningfully.

Training & Visits: Interaction amongst the teachers and students of both institution will give an insight in to the latest developments / requirements of the higher education; the First Party to permit the Faculty and Students of the Second Party to visit its institutional facilities and also involve in training programs about teaching, learning and evaluation for the Second Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from there rural background to working career. 

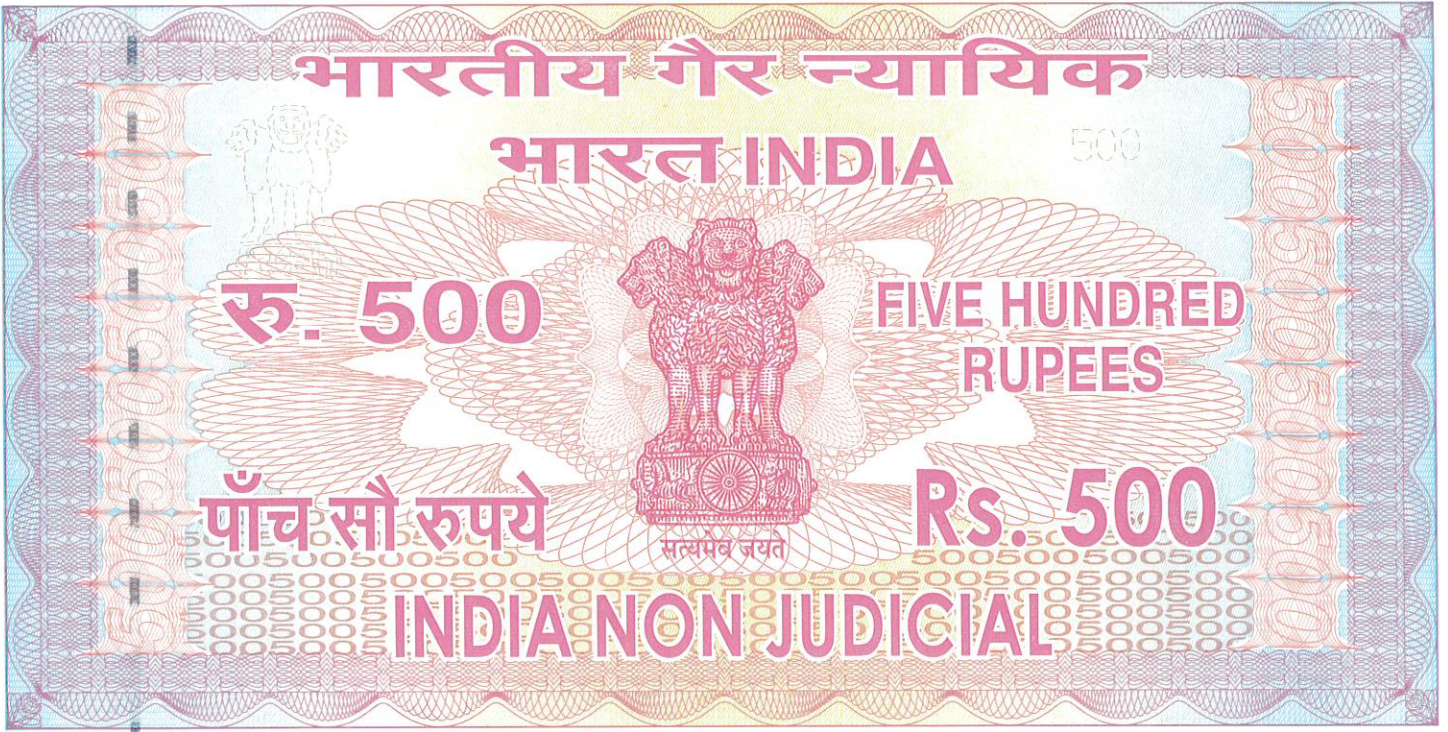

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

A) Progressive Education Society's Modern College of Arts, Science and Commerce (Autonomous), Ganeshkhind, Pune 411016, the First Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.

B) Swaraj College Of Arts, Commerce & Science, Gurudatta Housing Society, Pune - Satara Rd, behind Khushabu Hotel, Balaji Nagar, Dhankawadi, Pune, Maharashtra 411043, the Second Party is a Higher Educational Institution affiliated to Savitribai Phule Pune University aided/un-aided by State Government.

C) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.



D) The Parties intent to cooperate and focus their efforts on cooperation in overall excellence in teaching learning and evaluation

E) Both Parties, being legal entities in themselves, desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL UNDERSTANDING SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to Second Party in developing suitable teaching / training systems, keeping in mind the needs of the region of Mentee Institution.

The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

The budding graduates from the institutions could play a key role in, excellence innovation and competitiveness. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their knowledge.

Curriculum Design: First Party will give valuable inputs to the second Party in teaching / training methodology and suitably customization of the curriculum so that the students fit into the industrial scenario of their region meaningfully.

Training & Visits: Interaction amongst the teachers and students of both institution will give an insight in to the latest developments / requirements of the higher education; the First Party to permit the Faculty and Students of the Second Party to visit its institutional facilities and also involve in training programs about teaching, learning and evaluation for the Second Party. The training and exposure provided to students and faculty through this association will build confidence and prepare the students to have a smooth transition from there rural background to working career. The First Party will provide its labs / workshops / libraries for the hands-on training of the learners of the Second Party as per the availability of the facilities.



Research and Development: Both Parties have also agreed to carry out the joint research activities.

Capacity development Programs: First Party to train the students and teachers of Second Party on the emerging trends in higher education in order to bridge the skill gap and make them industry ready **Guest Lectures:** First Party to extend the necessary support to deliver guest lectures to the students of the Second Party (inter alia, by video conferencing) on the relevant topics/ trends and in-house requirements.

Faculty Development Programs: First Party to train the Faculties of Second Party for imparting training, in new pedagogies, innovative assessment and research methodology and other relevant topics.

Placement of Trained Students: First Party will actively engage to help the delivery of the soft skills and support in placement of students of the Second Party.

Guidance on Assessment and Accreditation Process: First Party will provide Guidance on Assessment and Accreditation Process by arranging Seminars/Workshops/Visits. They will also guide on NAAC process, Documentation required, Role of IQAC in quality enhancement of the institution leading to completion of NAAC process.

Funding: The funding for the Scheme shall be followed as mentioned in the Mentor-Mentee Guidelines prepared by the State Government. CLAUSE 4: VALIDITY

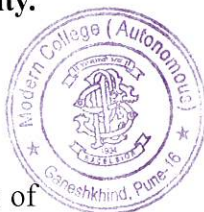

Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties must discharge their obligations.




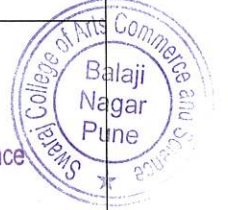
CLAUSE 5: DURATION OF MoU

Duration of MoU shall be of minimum one year or till the completion of NAAC process of Second Party.





PURPOSE

This Memorandum creates no charge/consideration/ cost/ monetary transactions between the Two Parties. Still, it shall be binding to maintain the independence of both parties in their respective area of work.

PREAMBLE

In the spirit of intellectual cooperation scholarly exchange, and the development of national partnership with institutions, Amity University Jharkhand and Progressive Education Society's Modern College of Arts, Science and Commerce agree to establish a program of exchange and collaboration on related matters of mutual interest that may emerge over time.

The MEMORANDUM OF UNDERSTANDING (MoU) made on 15th June 2021 between the **Amity University Jharkhand, Ranchi**, a private University under section 3 of the University Grants Commission Act, 1956 having its office at - **City Campus, Ranchi, Jharkhand, through Prof. (Dr.) Raman Kumar Jha**, Vice-Chancellor (hereinafter referred to as the party of the "**First Part / AUJ**") which expression shall, unless repugnant to the context thereof, include its, successors and assigns) and **Progressive Education Society's Modern College of Arts, Science and Commerce, having its office at Ganeshkhind, Pune** through **Dr. Sanjay S. Kharat**, its Principal (hereinafter referred to as the party of the "**Second Part / MCASCGK**") which expression shall, unless repugnant to the context thereof, include its, successors and assigns).

SCOPE AND OBJECTIVES OF MoU:

The scope and objectives of MoU are defined as:

AUJ and **MCASCGK** agree to sign this MoU for sharing academic ideas, offering internships, hands-on or on-job training to students/faculty of each signing party, project work for students, faculty/student exchange for collaborative research programs besides organizing joint events, mutually acceptable to each of the signing party and to get the Mutual Benefits.

DURATION OF MoU:

This MoU comes into effect from the date of its signing and will remain in force for a period of **FIVE YEARS**. Its validity can be extended by mutual agreement between both the parties.

RESPONSIBILITIES OF AUJ, RANCHI, JHARKHAND AND MCASCGK, GANESHKHIND, PUNE:

Common Roles of AUJ and MCASCGK:

1. The purposes of the cooperation are to promote cooperative research and to facilitate the exchange of ideas, the development of new knowledge, and to enhance high quality research acumen. The major thrust of the research on which the parties will cooperate i.e., **Academic Research.**

The modes of cooperation will include:

- (a) Exchanges of faculty and students for the purposes of research, teaching and events.
 - (b) The development and implementation of cooperative research projects, professional development programs, and capacity-building efforts.
 - (c) The dissemination of findings through scholarly publication, white papers and in the media.
2. To achieve the goals of this cooperation, both parties will, insofar as the means of each allow:
- (a) Promote institutional exchange by inviting faculty, researchers and student of the partner institution to participate in appropriate research activities.
 - (b) Organize symposia, conferences and meetings on timely research issues.
 - (c) Develop and carry out joint research programs, and
 - (d) Exchange information pertaining to the agreed-upon research areas.
3. Prior to the initiation of any particular project or activity, the specific terms of cooperation and exchange for that project will be discussed and agreed upon in writing by the appropriate responsible representatives of both institutions.
4. Both parties understand that all financial arrangements for specific exchange activities must be mutually agreed upon and will depend on the availability of funds. In addition, the scope of the activities will be subject to funds available at the institutions for the type of collaboration undertaken and any financial assistance that may be obtained by either from external sources.
5. Either party may propose to the other specific individual research projects for collaboration. Such proposal may be made at any time and the parties will develop an agreement for each agreed-upon project. The protection and exploitation of any intellectual property arising out of a research project will be addressed in each individual project agreement early on and ongoingly.
6. The fund of joint research project will be used 60% by the PI (Principal Investigator) and respective institution according to the mutual consent among PI and Co-PI (Co-Principal Investigator) following the term and conditions of respective funding agency.
7. Both institutions must adhere with research ethics and must go for approval by the national or/and international ethical committees.

8. Each institution agrees to release and hold the other harmless from and against any claims, damages, liability or costs, to the extent such claims damages, liability or costs arise from the negligent or willful acts or omission of the other university or any of its agents or employees in connection with their respective performance under this MoU.
9. The parties agree that in the course of implementing this MoU, they will not engage in unlawful discrimination on the grounds of race, gender, sexual orientation, age, religion, social class, national or ethnic origin or disability.
10. Amendments to this MoU may be made at any time after consultation and agreement between the two institutions. Any such amendment must be in writing and signed by both parties.
11. This MoU will remain in force for a period of five years from the date it is fully executed. The MoU can also be suitably modified, as agreed to by both the parties, to reflect an increased scope, nature of engagement/activities including financial commitments, if any. 3. Exchange of information through lectures and practicals relating to their activities in field of mutual interest.
4. Provide internship and summer training to the graduate (UG) /postgraduate (PG) students.
5. Provide Dissertation projects to the postgraduate (PG) students.
6. Arrange observer ship programs for the students.
7. Sharing of information periodically and regularly.

Common Activities by Both the Parties

1. Both institutions agree to supply workspace, library and technical facilities as applicable.
2. The consultancy and travel expenses related to the visits for lectures/sessions will be reimbursed by the host institute on mutually agreed terms.
3. The MoU may be amended, renewed and terminated by mutual written agreement between the Heads of both the institutes.
4. Either institute shall have the right to terminate this MoU upon 60-day prior notice period to the other Institute.
5. AUJ and MCASCGK mutually agree to exchange staff / students for their projects, clinical training/internship, on job training, project work, and student/faculty exchange and for collaborative research programs to get the Mutual Benefits and the charges will be borne by individual students as per the institutes rules and regulations.

e. Order of Precedence.

f. Entirety.

This Agreement represents the entire agreement and understanding between the parties with respect to its subject matter and supersedes any prior and/or contemporaneous discussions, representations, or agreements, whether written or oral, of the parties regarding this subject matter.

g. Amendments.

The Amendments or changes to this Agreement must be in writing and signed by duly authorized representatives of both the parties. 



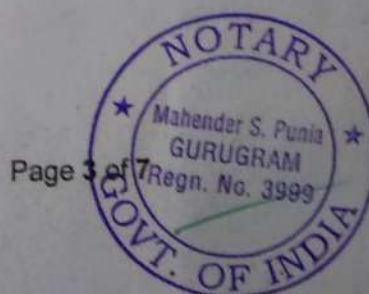

The goal of this cooperation is to foster collaboration, provide opportunity for mutually beneficial experience and to facilitate advancement of knowledge on the basis of reciprocity. The MoU between the Sri Venkateswara College, New-Delhi and Modern College, Ganeshkhind, Pune include the following:

1. Student/staff exchange for academic and research internship during the period of mutual availability
2. Activities involving mutual exchange, teaching, research and industrial/conversational practice, joint proposal for research grant, conferences (national and international level)
3. Publishing joint research work and other academic publications such as books, manual etc.
4. Organizing capacity building programmes such as workshop, trainings and seminars
5. Community outreach activities through involvement of students and staff
6. Encouraging students to work excessively in the field of life sciences, wildlife and conservation biology
7. Co-planning certificate / diploma courses of mutual interest (Planning handling and implementing academic and Co-curricular courses for students) (preferably involving curricular based on skill India program).
8. Encouraging staff exchange or guest lecture series.



9. Fundraising for research and capacity building.
10. Research Dissertations leading to Masters degree.
11. Exchange students will be selected by mutual agreement between the parent institution and the host institution.
12. An exchange student will continue to be treated as full-time student at his/her home institution.
13. An exchange student will be considered as a full-time "exchange" student at the host institution.
14. His/her program of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
15. If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a technical "report" of the research carried out. The home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
16. Both the parties agree to provide assistance in obtaining suitable accommodation at reasonable expenses (expenses will be borne by the student).
17. The exchange students will pay tuition and other fees at their home institution.
18. Basic lab facilities will be provided by the host institution, however any extra ordinary chemical or instrument facilities required will be chargeable (expenses will be borne by the student)
19. Guidelines will be decided based on mutual agreement for research paper publication, department/ faculty level collaboration. A road map for joint activities related to joint research proposal submission for major minor research grants in various funding agencies needs to be formulated.
20. This MoU shall continue in force for five years from the date hereof and may, by mutual consent of both the organizations set down in an exchange of letters, continue in force from year to year thereafter.
21. This agreement could be renewed with mutual understanding and agreement between two organizations after the expiry of its validity period with or without any amendment or modification. Either party has the right to terminate this agreement upon six month written notice to the other. However, any research work, Ph.D., or pursuit of any other degree already



initiated at the time of such a termination shall be continued till the completion of such research works or degree, as the case may be, in the same manner and under the same terms and conditions as those during the currency of the agreement.

22. This MoU does not impose any financial burden on the parties.

23. Nothing contained herein would restrict the Sri Venkateswara College, New-Delhi and Modern College, Ganeshkhind, Pune to enter into a MoU with other university / academic institutions for similar research or academic works on any or all subjects.

2. **Purpose** : The purpose of this MOU is to establish the terms and conditions under which grant can be given to deserving post graduate student(s) of Physical Sciences and of Biological Sciences of PES's Modern College of Arts, Science and Commerce, Ganeshkhind, Pune by Dabake Trust. The research projects which are directly contributing to betterment of environment, development of user friendly technology, making the life easier of human kind with lower cost and have innovative solutions; are given the priority while selecting for the grant.
3. **Terms of MOU** : This MOU is effective upon the day and date last signed and executed by the duly authorized representatives of the PES's Modern College of Arts, Science and Commerce, Ganeshkhind, Pune and Dabake Trust, to this MOU and shall remain in full force and effect for three academic years starting from year 2020-21. This MOU may be reviewed afterwards for the usefulness of this grant, by both the parties with mutual consent.
4. **Responsibilities of PES's Modern College of Arts, Science and Commerce, Ganeshkhind, Pune** :

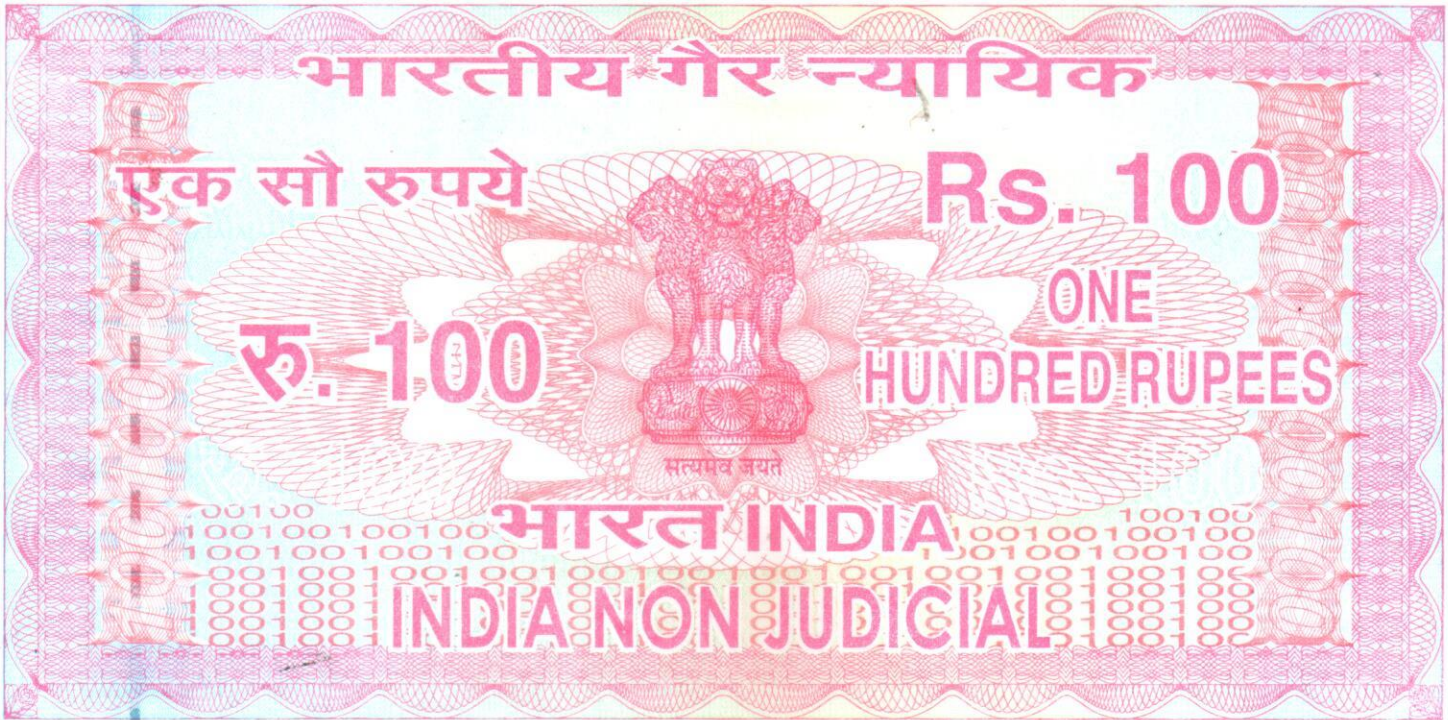

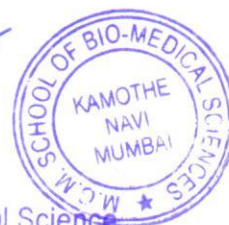
Common Activities by Both the Parties

1. Both institutions agree to supply work space, library and technical facilities as applicable.
2. The consultancy and travel expenses related to the visits for lectures/sessions will be reimbursed by the host institute on mutually agreed terms.
3. The MoU may be amended, renewed and terminated by mutual written agreement between the Heads of both the institutes.
4. Either institute shall have the right to terminate this MoU upon 60 days prior notice period to the other Institute.
5. Both the institute and industry i.e. MGMSBSBT and MCASCGK will organize conferences, workshops, seminars etc. The faculty, students and staff shall be

encouraged to participate in such activities so as to interact with each other for their academic and professional growth; such programmes will be conducted by both the institutions with information to each other in advance, as and when required.

6. MGMSBSMBT and MCASCGK mutually agree to exchange staff / students for their projects, clinical training/internship, on job training, project work, and student/faculty exchange and for collaborative research programmes to get the Mutual Benefits and the charges will be borne by individual students as per the institutes rules and regulations.
7. MGMSBSMBT and MCASCGK mutually agree to help each other to establish and develop laboratories, research centers, etc. as and when required.
8. Faculty of MGMSBSMBT and MCASCGK depending on their qualifications and experience can act as co-guides to the students pursuing the M.Sc and Ph.D. programmes at MGMSBSMBT and MCASCGK as the case may be.
9. Areas for faculty development shall be identified and joint proposals shall be submitted to various funding agencies like ICMR, DST, DBT, BRNS, and RGSTC etc.
10. Both the institutes will participate in relevant government programs / schemes to take mutual benefits of Institute - Institute collaborations where ever possible.
11. MGMSBSMBT and MCASCGK mutually agree that Publications of the joint research carried out will be done jointly by both the Institutes incorporating the names of all the contributors
12. This document is in no way intended to create a legal or binding obligations on either party. It serves only as a record of the parties' current intentions to enhance relationship of the Institute and Institute going forward.

General Conditions:

1. The MoU will be valid for a period of 5 years to ensure smooth conduct of the activities under the MoU and to achieve the objective of the MoU. The parties may further extend/renew the MoU on terms and conditions as mutually agreed. Within the aforesaid period of 5 years, the MoU may be terminated only by mutual consent.
