15. Multidisciplinary / interdisciplinary

• Academic autonomy has been granted to the institute from the coming academic year (2022-23). The institute being multi-disciplinary, process of designing syllabi for academic programmes would take care of inclusion of multi-disciplinary

elements. • Different departments have planned interdisciplinary value-added courses to be offered in autonomous structure. • Currently B.Voc. (Food Processing), BBA (CA) and Biotechnology programmes are offering multi-/inter-disciplinary syllabus. • Some of the Departments conduct collaborative experiential learning activities viz. B.Com. students understand constitutional process of passage of a bill during Mock Parliament. Some of the departments screen movies and provide resources jointly on inter-disciplinary contents. • Courses viz. Environmental Studies and Democracy, Decentralisation and Governance offered at UnderGraduate are inter-disciplinary. Credits on Human Rights, Introduction to Constitution and Cyber Security offered at PG level are inter-disciplinary. • Certificate / Value Added Courses and specialized courses offered by Departments in Humanities viz. Modi Script, Spoken English are multi-disciplinary in nature. • Students are encouraged to take up multidisciplinary courses and MOOCs available on Swayam, e-PGPathshala and NPTEL portals. • We are engaged in multi and inter-disciplinary research for instance department of Biotechnology, Zoology and Microbiology are working on antimicrobial resistance in the environmental components and combating it with natural products and nanomaterials. Under DBT BUILDER programme multidisciplinary, theme based research projects are proposed besides value-added programmes and hands-on workshops for skill enhancement. • Single faculty colleges located in our vicinity and run by our own parent institution (School of Law and Judiciary and School of Education) can be associated as multidisciplinary college to conduct collaborative certificate and value-added courses.

16.Academic bank of credits (ABC):

• Being recently granted fresh autonomous status, the institute is in process of registering on Academic Bank of Credits (ABC) via the National Academic Depository (NAD). This would enable student mobility and academic flexibility. • Currently we run a B.Voc. Food Processing UG course, which has inbuilt academic flexibility with option of multiple entry and exit. • We are preparing asynchronous content enabling students to learn at their own pace and their own learning path ensuring flexibility. We already have established and effectively using an LMS : Moodle which can be integrated for ABC. • For MIL course offered by the affiliating University at SYBA, redemption of credit was done for Urdu course with Abeda Inamdar College, Pune. • Sessions are conducted for students by inviting established researchers and academicians from India and abroad for exposing them to current

knowledge and recent developments in different areas. • Science Academies' Lecture Series and Refresher Courses have been arranged for students and teachers from our college and outside with most of the speakers/resource persons being fellow of apex Science Academies of India.

17.Skill development:

• NEP emphasizes on skill development as a tool for empowering youth by bridging the skill gap. • Skilling enhances the employability : college conducts symposia, conferences/seminars, workshops, hands-on-training programmes, interactive sessions, engage students in project-based learning • Use of Virtual Lab and virtual dissection for practical purpose is conducted • MOUs with industry (Manufacturing, IT and Service Sector) are signed for internships. • Industrial and study tours are regularly organised • College jointly with Industry organises Soft Skill workshops for final year students. Some of the departments regularly organise department-specific soft-skill workshops • College is conducting value added skill development courses for instance Quality control in laboratory, Computerised Accounting in Tally and Spoken English • Special thematic areas have been identified for research and training under DBT BUILDER programme • Summer/Winter Schools : students are sent to institutes of high repute for their Summer/Winter schools and research projects • DBT MANAV : Students from life sciences are actively participating in Government of India, Department of Biotechnology (DBT) MANAV (Human Genome Atlas) programme • Internships/Apprenticeship/OnJob Training : students are motivated and provided necessary support for internships/apprenticeships/onjob training programmes. (Students from Commerce faculty regularly work in Banks on-job trainings, Psychology students work in NGOs on mental health and related issues and students of Sociology work in education sector) • Expert Lectures : experts are regularly invited for interactive sessions, guidance and expert-lectures for students and faculty members (DBT STAR Lecture Series consists of lectures from the experts from Industry and Academia and are open for all to participate, National Science Academies' Lecture Series and Refresher Programmes, FDP under Teaching Learning Centre, GOI have been conducted) • Specific Practical and hands-on training programmes conducted under DBT Star • Research induction programmes have been organised for Post Graduate students • 'Vividha' for developing entrepreneurial skills • Employer and Industry representatives on IQAC guide on required skills for enhancing employability. • Industry-AcademiaAlumni Forum has been

established to get inputs from industry on design of curriculum, training and other collaborative activities. • Industry representatives have been inducted on newly constituted BOS of Autonomous College (Academic Year 2022-23). These experts would guide on required skill-set for Industry 4.0.

18.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

College is taking substantial efforts to revive and popularise Indian traditional knowledge by designing and conducting special courses for instance Vedic Mathematics, Modi (Medieval) Script which was used during Shivaji Maharaj era • Under-Graduate and Post-Graduate programmes in the faculty of Arts and Commerce are taught in bilingual way (English and Vernacular) • Marathi, Hindi and Urdu are covered in Modern Indian Languages training, Vachan Prerna Din (Day for cultivating reading habit) and Marathi Raj Bhasha Din are commemorated annually. Book reading club has been started • Ranbhaji Mahotsav : wild vegetables consumed by tribes are exhibited • College organises Tribal Handicrafts Exhibition and workshop on Tribal Arts. • Swar Madhuri : a state-level, university sponsored competition on Classical forms of music is an annual event since 1994-95. • Various activities under Arts circle themed on Indian history, culture and national integration • College magazine, Akanksha covers and highlights Indian culture and encourages international students to know and explore the Great Indian traditions • Some departments publish in-house magazines themed on Indian traditional knowledge and allied systems (Pramey by Department of Mathematics) • Students and teachers are encouraged to undergo Swayam/NPTEL on these subjects. Many of them has successfully completed.

• College emphasises on Outcome based learning • College has devised a formal mechanism for mapping of Programme Outcomes (PO) and Course Outcomes (CO) • College has developed a CO/PO manual that covers course attainment and Graduate Attributes • Performance in University examinations, securing ranks and Gold Medals • Rank holders in national level professional examinations (CA/CS/CMA) • Outcomes include Placement, Research Publications, Participation in events, Intellectual Property, performance in competitive examinations (MPSC) and discipline specific exams (NET/SLET, GATE, JAM, BET) • Under Autonomy we can pay more attention to monitor OBE.

20.Distance education/online education:

• College is an authorised centre offering Distance Education under the name of School of Open Learning of Savitribai Phule Pune University (Affiliating University). Teaching faculty is roped in for dissemination, paper setting and evaluation. • Some of the teaching faculty have contributed for preparing study material and a few teachers have prepared online course for Swayam/NPTEL. • Under the proposed autonomous structure, we are planning to introduce our own distance learning courses. • We are fully using a customised Learning Management System : Moodle, besides Microsoft Teams, G-Suit, Live Streaming of college events is practiced • Infrastructure for e-learning • Capacity building of faculty for online teaching has been done • Teaching faculty reaching out as resource persons for training in distance and online education • Blended BSc Program has a component on hybrid education with Melbourne University, Australia.

Human values are taught by discussing spirit of healthy Nationalism, Democratic Values and Secularism as per curriculum.

Issues relevant to Environment and Sustainability:Environmental Studies is a compulsory credit course for all Second Year U.G. students to learn about Environmental Pollution Control Technologies and measures for conservation of environment.

The Controller of Examinations appointed by the Principal from among teachers in the college, manages various examination operations with the help of the Examination Committee, office administrative staff and internal examination committee. Examination cell has set up a vision providing robust and transparent evaluation system.

The Office of the Controller of Examinations integrated the Information Technology in the management of Examination System by purchasing dedicated software for examination reforms. Mark entry, Grade, Percentage and Cumulative Grade Point Average (CGPA), preparation and analysis of results are automated. The mark statement of every semester is accessible to restricted users, especially to the Heads of the Departments to assess the performance of students periodically and guide them properly.

In the examination Management System (EMS) and reforms a Pattern with 30 Percent formative evaluation (Continuous internal evaluation CIE) and Summative evaluation (70 Percent). CIE was based on closed-book and open-book tests; problem-based assignments; practical assignment laboratory reports; observation of practical skills; individual project reports (case-study reports); team project reports; oral presentations, including seminar Presentation; viva voce interviews; computerized adaptive testing; peer and self-assessment etc. and any other pedagogic approaches and use of Blooms taxonomy for question paper preparation of ESE.

INFRASTRUCTURE AND LEARNING RESOURCES

4.1 - Physical Facilities

4.1.1 - The Institution has adequate infrastructure and physical facilities for teaching-learning, viz., classrooms, laboratories, computing equipments, etc.

Modern College, in Pune, spans 3.5 acres with 3 buildings, offering 9 Undergraduate, 13 Postgraduate courses, and 4 research centers. It operates morning and afternoon shifts to optimize resources. Infrastructure includes ICT-enabled classrooms, laboratories, computers, a library, examination center, IQAC Room, administrative office, audio-visual hall, amphitheater, staff rooms, restrooms, parking, canteen, sports facilities, and green energy resources like a Hybrid Solar-Wind Power Generation Plant and gardens. There are 37 well-equipped classrooms, some using solar-wind energy, with seating for 30 to 100 students. Specially-abled students have ground-floor classrooms, and audiobook facilities aid blind students. Smart boards and 10 large interactive flat panels are available, and ICT tools like internet, LCD screens, laptops, and headphones/microphones are present. The college has 42 laboratories with high-end equipment, A Central Instrumentation facility hosting high end equipment including qRT-PCR (Quantitative Real-Time PCR), FTIR (Fourier-transform infrared) spectroscope, AAS (Atomic absorption spectroscopy), Nanodrop Spectrophotometer, HPLC (high performance liquid chromatography), Deep-freezer (-86°C). Special Labs like Animal Tissue Culture (BSL2), Plant Tissue Culture and Bioinformatics are present. Chemistry labs featuring fume hoods and recycling practices. The campus has 56 CCTV cameras. Computing equipment includes 552 desktops, 54 laptops, and software like MATLAB and SPSS, Office-365 A1 Plus, URKUND etc. The library houses 20,556 reference books, 18,028 textbooks, and digital resources, with facilities for visually impaired students. Administrative cabins are provided for the Principal and Vice-

Principals.

The college offers a range of cultural, fitness, and sports facilities to its students and staff. Inaugurated in 2007, the air-conditioned Audio-Visual Hall boasts an area of 1200 sq.ft and accommodates 150 people. It features various amenities including a podium, water purifier, microphones, and ICT facilities. The hall serves as a venue for cultural activities like competitions, workshops, and guidance sessions. Additionally, there's an open-air Amphitheater with a 21 feet X 18 feet dimension stage having all advanced light and sound system arrangements, seating for over 400 individuals in the audience, used for performances and events. The Arts Circle has a dedicated room for storing musical instruments and stage materials. The college maintains a booking register for the AV Hall, and regularly utilizes the auditorium with 500 seating capacity at the parent institute for major events. Fitness enthusiasts can access the indoor gym established in 1995, equipped with high-grade instruments for a full-body workout. Analytical instruments are available for monitoring progress. There's also an outdoor gym with various workout equipment. Sports facilities include indoor games like chess and table tennis . Outdoor facilities include volleyball and basketball courts, as well as open badminton courts. Sports supplies are issued as needed, and infrastructure is used for physical education, competitions, and demonstrations. Additionally, a yoga center conducts guidance sessions for staff members, with ample yoga mats available. Indoor badminton court with international standards is available at the parent institute's Shivajinagar campus.

Additionally, the library employs DSpace for digital content management, hosting an Institutional Repository on the college website. This repository encompasses faculty publications, syllabi, question papers, free e-books, and audio books tailored for visually impaired students, ensuring inclusivity. For plagiarism check, Urkund Software is used. Visually impaired students benefit from Braille books, computer training centers, and audio book resources, supported by screen reader software like Jaws 2018 and NVDA. The college's accessibility measures, including wheelchairs and on-demand book services, prioritize inclusivity and support for differently abled students.

The college continually upgrades its IT infrastructure, In 2022-23 college has augmented it by adding 10 Interactive flat panels of 75 inch for teaching , Dell power edge server for extended cloud storage , 50 desktops with i5 10th generation processors,16GB RAM for students and 4 high grade laptops for staff. The up gradation includes featuring advanced Pentium-IV microprocessors, memory configurations ranging from 2GB RAM to 16GB RAM, and operating systems from Windows 7 to 10, alongside CENTOS. A total of 552computers, including 78 all-in-one units. Bandwidth has expanded to 250 MBPS, with 24 routers supporting up to 100 users each. Administrative staff utilize 27 laptops, while 27 HP laptops with 8GB RAM and 256 SSD are designated for Statistics laboratories. Online admission for candidates is facilitated through Vriddhi and Digital Edu software. Classrooms are equipped with 40 projectors, 4 smart boards, 10 Interactive panels of 75 inch and televisions. Printing is supported by 74 printers. High-capacity printers and scanners are used in examination. Thermal stability is maintained by 40 AC units, while server facilities include 5 physical and 6 virtual servers. Office-365 A1 licenses for 5000 students and 500 staff members have been procured from Microsoft, with additional licenses obtained in 2020. Licensed

software like MATLAB and SPSS ensures a secure computing environment. When designing the college budget, significant emphasis is placed on upgrading its IT facilities. The budget is allocated towards acquiring various ICT-based tools for teaching, administration, improving cloud space and cyber protection.

IQAC has adopted quality improvement strategies in areas like curriculum-development, teaching-learning, examination evaluation, research and development. Skill-based courses are designed keeping in view the demographic diversity. College runs its self-designed curriculum for Bachelor of Vocation (Food Processing) and BSc Blended (Chemistry) programmes. IQAC gathers feedback from all stakeholders, based on which teachers are suggested to conduct bridge, add-on and remedial courses and to use ICT-based teaching methods to improve the teaching-learning process. IQAC has focused on the implementation of e-governance in Planning, Administration, Finance and Accounts, Admission Process, Examination and Evaluation. All computers in college are connected through LAN. This also gives accessibility to the Management to scrutinize and verify all the activities conducted by different departments of the College. A systematic format for collection of relevant information along with documentary evidence is developed by DVV committee constituted by IQAC. The college has adopted customized Moodle LMS for sharing study material, submission of assignments and conducting online examinations. The College has also subscribed to G-Suite and Microsoft Teams to conduct online lectures. IQAC initiates Capacity Building Programmes for teaching and administrative staff.

The college has a functional IQAC constituted as per the norms. IQAC has constituted a feedback committee which seeks feedback regularly from all stakeholders. Based on the feedback cognisance is taken. IQAC initiated training programme for introducing use of ICT in teaching-learning and evaluation. To equip teachers to acquaint with communication technology, workshops are conducted on new ICT tools and developments in learning management systems. A customised LMS, Moodle has been developed that integrates teachers and students for teaching-learning and evaluation process. Teachers upload study material and learning resources on Moodle. Technology-enabled learning has helped to minimize physical distance. Facebook Live and YouTube live are the platforms used to organize online events, competitions and lectures for learning different skills. IQAC organises departmental presentations and discussion sessions to share knowledge and exchange various teaching methodologies adopted by different teachers. IQAC organised training sessions for defining learning outcomes, understanding Graduate Attributes and also for understanding the procedure for calculating attainment thereof. Teachers were guided for mapping of syllabus with Programme Outcomes and Course Outcomes and for enumerating course outcomes for their respective courses

7.1.3 - Describe the facilities in the institution for the management of the following types of degradable and non-degradable waste (within a maximum of 200 words)

Waste management is very important as it reduces the toxic impacts on the environment. Organic biodegradable waste including canteen waste is processed in the Baction-composting unit installed by Nila Polycast Baction. 100 Kg garbage is processed in a week. To treat laboratory waste water our college has installed the Effluent Water Treatment Plant (2000 liter) which cleans the effluents from the wastewater. This recycled water is used for plants in the campus. Similarly the waste water coming out from the RO plant is systematically utilized for plants in the campus.

Used solvents are either recycled by using Rota evaporator or before disposal of chemicals students dilute chemicals by treatment and then discarded.

Biowaste is segregated into dry, wet, sharp and stored in separate colour bags before being given to 'Pasco Environmental Solutions'. Biomedical waste like microbial cultures and media are autoclaved before disposal.

The College has signed a MoU with DP Raddi Depo & suppliers through which all the e-waste in the college campus has been taken

care of. Other scrap material like metal, wood, glass, etc. is given to scrap dealers for recycling. Paper waste (Raddi) is also given for recycling.

Radioactive waste is not generated in the campus.

7.3 - Institutional Distinctiveness

7.3.1 - Highlight the performance of the institution in an area distinct to its priority and thrust (within a maximum of 200 words)

A distinctive feature of our college is its sincere efforts in adoption of problem based teaching-learning supported by research aptitude among students of all faculties. Most of the undergraduate students have participated in a variety of community-based projects, and they continued till the end of their degrees. Financial support for this project have been provided to students through a variety of sources including the funds received from RBI, DBT Star College scheme, DBT BUILDER Scheme and support from various NGO. Over 1500 undergraduate and 700 postgraduate students have conducted independent research projects as part of the DBT Star College Scheme, which is still in use today. More than 200 participants got benefited through Hands on training workshops organized under DBT Builder scheme. Under PMMSY 34 samples of 11 different fish species are screened in the laboratory. Students detected the sources of mass fish mortality in Jambhulwadi Lake and reported their findings to PMC in May 2023. Forty students have been participated in Eco restoration projects at Khatpewadi Lake and Someshwar Kund in collaboration with Kirloskar Vasundhara club, Pune. Over 45 students of Commerce Faculty are working as "Bank Mitra Volunteers" and near about 200 people got benefited in 2022-23.
