## The following are the alumni funded scholarships

## 1. Gollapudy Scholarship I/II/ III

#### Introduction

- 2. Minimum marks at previous exam of 55% without any backlog.

- 3. Students having adverse economic conditions.
- 4. Student having shown the progression in academic performance.

Apart from general conditions the students can apply for this scholarship if they satisfy the following criteria

- 1. Upward moving graph of academic performance
- 2. Student having startup
- 3. Extra ordinary contribution in NCC or NSS of college

# 2. Atal Scholarship and Rani Laxmibai Scholarship

#### Eligibility of an applicant for Atal scholarship

An applicant who is interested to avail mentioned scholarship is required to fulfill the following general conditions.

- 1. Second or third year Student of Arts, Science and Commerce faculty
- 2. Minimum marks at previous exam of 55% without any backlog papers
- 4. Students having adverse economic conditions.

## Eligibility of an applicant for Rani Laxmibai scholarship

An applicant who is interested to avail mentioned scholarship is required to fulfill the following general conditions.

- 1. Second or third year **girl** Student of Arts, Science and Commerce faculty
- 2. Minimum marks at previous exam of 55% without any backlog
- 3. Students having adverse economic conditions.
- 4. Preference will be given to girl student who has started her own business

#### 3. Prerana Puraskar

#### Introduction

Jyoti Mungse was our alumnus from Arts faculty who had completed BA and MA with sociology by fighting to her illness. She was social worker and had her own charitable institution known as Hrudayajyot Pariwar for the heart decease patients. Unfortunately she has passed away in May 2019. Before her demise she had expressed to institute scholarship in the

form of Prerana Puraskar to the deserving student from the year 2016-17.
